You can pay with cash, a check payable to Carteret CC Foundation or credit card. If paying by credit card, you can complete the credit card section above call 252-222-6268 to make a payment by phone. **All applications and payments must be received by May 6, 2022.**

Setup and Breakdown (outdoor only):

Vendor setup between 9 a.m. – 11:30 a.m. on Saturday morning. Do not mount, tape or setup anything on the walkway. Please bring your own tent (10'x10' only, one per space), tables and chairs, and table coverings. No electrical hookups available, no generators allowed. We ask that you are setup and your car re-parked to designated vendor parking by 11:30 a.m.

Concessions:

There will be food and drink available for purchase from the carnival during the day and during the concerts (6:30 p.m. – 10 p.m.). Vendors are allowed a cooler for personal use only.

A map is included marking the Vendor Area and parking. The staff of the Carteret Community College Foundation, Inc., will assign vendor booths. There is no guarantee of receiving a particular or requested booth location. All spaces will be marked. We ask that you stay within the marked space, one space per \$50. No refunds will be issued, rain or shine event. **Application deadline date: Friday, May 6, 2022**
